Explanations of the 5 line items that were over the 5% variance and over \$1,000 included: Gateway Human Trafficking (presentations), Our Lady's Inn (teen parents), Preferred Family Healthcare (Outpatient Substance Use Treatment – group counseling), and Youth In Need (Transitional Living) were due to high demand. Kids Under Twenty One (prevention) was over the variance due to school-based usage.

A motion was made to approve a wire-transfer for \$413,000.00 for the month of December. (M.S.P.: Dempsey/Marty) – Motion passed.

All of CCRB invoices and bills paid were completed with 100% accuracy.
