ABOUT THE CCRB

- Contracts with local nonprofit agencies who provide mental health and substance use treatment services for children under age 19 in St. Charles County.
- Oversees the administration and distribution of the Children's Community Services Fund, which is funded through a 1/8 cent sales tax.



ABOUT THE CCRB

Targeted funding and high-quality services contributes to St. Charles County consistently ranking in the top 3 for overall child well-being in Missouri, as determined by Missouri Kids Count.

- The CCRB allocates about **\$10 million** in youth mental health and substance use treatment services annually.

CCRB CORE SERVICES FUNDING CYCLE

Month	Activity
May	Concept Papers are made available May 1 in CCRB application portal. Applicants submit a Concept Paper for New Program - Due May 15 by 2 PM
June	Funding applications made available June 1. New programs - Annually Existing programs - Bi-annually beginning with FY2022
August	Applications due August 15, 2023 by 2 PM Application summaries created for each application
October	Applicants meet with the CCRB Executive Director to discuss the application, summary, and November Board hearing
November	Applicants are invited to present to the Board of Directors
December	Funding decisions are made at the December Board meeting



CORE SERVICE FOCUS

There are many types of programs that qualify for Core funding, including:

- Programs that enhance the social and emotional capacity of children and youth
- Family strengthening programs
- Youth development and empowerment services
- Programs that promote physical and mental health prevention and intervention
- Services that focus on healing from trauma
- Substance use education, prevention and intervention programming
- Individual, family, group, or community-wide services that promote wellbeing

ELIGIBILITY



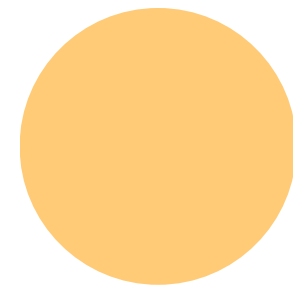
Applicants must:

- Be public or nonprofit agencies (501 c3) with programs that impact mental health or substance abuse outpatient treatment in St. Charles County.
- Be in good standing with the MO Secretary of State.
- Be accredited, in the process of being accredited, and/or receive a certification and/or review from an outside source approved by the CCRB. Exemptions may be requested.
- Have conducted an independent financial audit within the past 12 months.
- Require background checks, including child abuse and neglect screenings, to be conducted on all employees and volunteers.
- Provide employment and services regardless of race, color, religion, sex, national origin, age, or other non-merit factors.



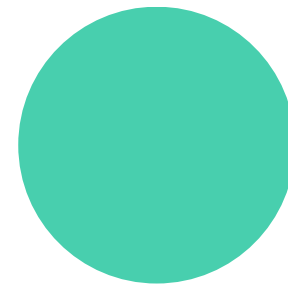


SERVICE RECIPIENTS



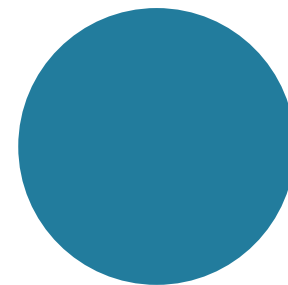
RESIDENCY

Service recipients must live in St. Charles County or be residents by court order, such as in juvenile justice or foster care involvement.



AGE LIMITATION

Clients must start treatment with your agency before their 19th birthday, but may continue to receive services, and have them be reimbursable until they turn 20 years of age.






YOUTH-FOCUSED

Services must involve the care or treatment of a child or youth; caregivers and professionals are eligible for child-centered services.



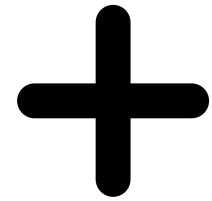
NON-REIMBURSABLE SERVICES

-  Capital campaigns, construction, and building expenses.

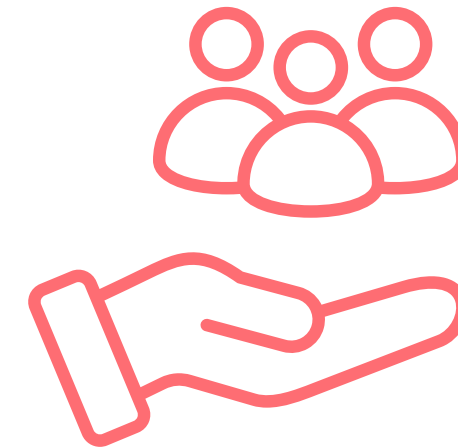
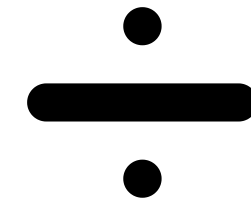
UNIT RATE MODEL

Indirect Expenses



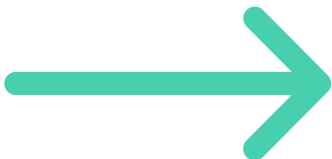
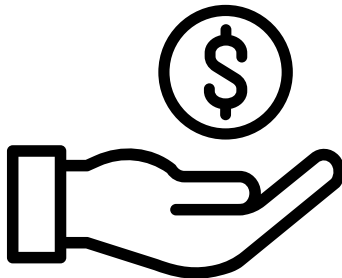

BILLING MODEL

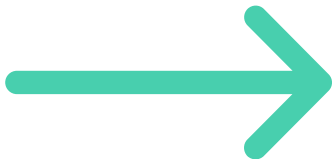
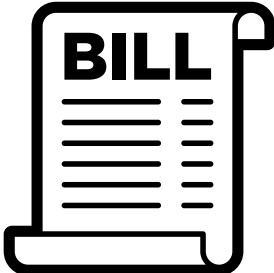
CCRB awards program a contracted amount.



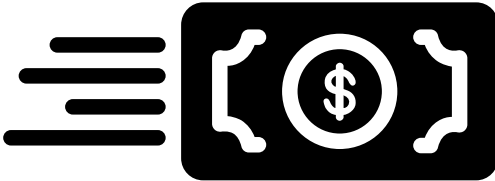
Program serves clients.

PARTNER EXPECTATIONS

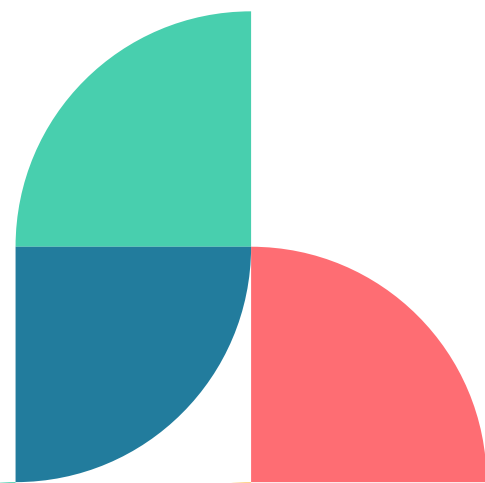
- **Monthly** reimbursement submissions
- **Documentation** for each service provided.
- **Site Audits** conducted bi-annually to verify age, residency, and billing for CCRB-funded services.
- **Clinical Outcomes Goals** to measure program impact and client progress. Minimum of three per program.
 - **Annual Outcomes Report** detailing progress and client demographics due February 15.
- **Audited Cost Analysis** conducted by an independent auditor after initial funding year.

CCRB COMMITMENT

NEXT STEPS

MEET WITH CCRB

Schedule a meeting with the Executive Director and the CCRB to discuss program and eligibility.

CONCEPT PAPER

Request access to the CCRB application portal, complete the Concept Paper, and submit by 2 PM on May 15.

RESPONSE

Response to Concept issued no later than June 1. Approved programs will be invited to submit a full application.
